Procedure for Manufacturer recognition under Boilers Act, 1923

Step 1:

- Applicant creates an account at Jharkhand Single Window at www.advantage.jharkhand.gov.in and chooses "Labour" after logging in.
- Create Account -> Login -> Labour -> Recognition of Manufacturer of Boiler & Steam Pipes under Boilers Act
- Required Items: Mobile Number and Email Id

Or

- Through Labour Department's 'Shramadhan' Portal <http://shramadhan.jharkhand.gov.in>
- Create Account -> Login -> Services -> Boiler Act -> Vendor Section -> Vendor Registration
- Required Items: Mobile Number and Email Id

Step 2: Applicant has to start filling form and provide:

Step 3: Chief Inspector of Boilers verifies all credentials and inspects the establishment along with concerned Inspector of Boilers

Step 4: Chief Inspector of Boilers approves / rejects application for Renewal of Boiler Manufacturer Recognition within 30 days from the date of application.

- Online system sends SMS to respective officers and applicant at each stage of progression.
- In case of any clarifications, the applicant is informed on actions to be taken and start date will be after all the clarifications have been received.
- Online application process requires no physical touch point.

Procedure for Renewal of Boiler Manufacturer Recognition under Boilers Act

Step 1:

- Through Jharkhand Single Window for Industries
- Applicant creates an account at Jharkhand Single Window at www.advantage.jharkhand.gov.in and chooses "Labour" after logging in.
- Create Account -> Login -> Labour -> Renewal of Boiler Manufacturer recognition
- Required Items: Mobile Number and Email Id

Or

- Through Labour Department's 'Shramadhan' Portal <http://shramadhan.jharkhand.gov.in>
- Create Account -> Login -> Services -> Boiler Act -> Vendor Section-> Vendor Renewal
- Required Items: Mobile Number and Email Id

Step 2: Proceed to Renewal and pay fee through Treasury Fee Challan/ Online Banking fee payment

Step 3: Chief Inspector of Boilers verifies all credentials

(CIB may inspect the establishment along with concerned Inspector of Boilers if the recognition for the class of boiler is to be upgraded)

Step 4: Chief Inspector of Boilers approves / rejects application for Renewal of Boiler Manufacturer Recognition within 15 days from the date of application.

- Online system sends SMS to respective officers and applicant at each stage of progression.
- In case of any clarifications, the applicant is informed on actions to be taken and start date will be after all the clarifications have been received.
- Online application process requires no physical touch point.
