In exercise of powers conferred by Section-40 of the Jharkhand Shops & Establishment Act, 1953, the Governor of Jharkhand is pleased to make following amendments in the Jharkhand Shops & Establishment Rules 2001.

1) Short Title, Extent and Government :-

- i. These Rules may be called the Jharkhand Shops & Establishment (Amendment) Rules-2012.
- ii. It shall extend to the whole State of Jharkhand.
- iii. It shall come into effect from the date of notification.

2) Rule 3A of the Jharkhand Shops & Establishment Rule 2001 is hereby repealed.

3) Substitution of the Rule 3B of the Jharkhand Shops & Establishment Rule 2001.

Rule 3(B) of the Jharkhand Shops & Establishment Rule 2001 shall be substituted by the following :-

“Validity of the certificate of registration Every certificate granted under Rule-3 shall remain valid till the closure of the concerned Shops & Establishments”

4) Rule 3(2) of The Jharkhand Shops and Establishment Rule 2001 is amended as follows :-

5) Substitution of Rule 7 of the Jharkhand Shops & Establishment Rules 2012 :-

Rule 7 of the Jharkhand Shops and Establishment Rule 2001 shall be substituted by following :-

Late application for registration or amendment

“7- If an application for registration of an establishment or amendment of registration certificate is not received by the Inspecting Officer within time specified in the foregoing rule the establishment shall be registered or the registration certificate shall be amended, as the case may be, on payment of a fee calculated in following manner, The process of

Registration or amendment shall be completed and for the delay of every subsequent 3 months or part thereof 50% additional fee on the prescribed original fee shall be payable in one installment.

- 6) In Sub-rule (1) of Rule 21 of the Jharkhand Shops and Establishments Rules 2001 the words "and other wise terminated" shall be inserted between the words "dismissal and discharge" and "under section 26"
- 7) In Sub-rule (2) of Rule 21 of the Jharkhand Shops and Establishment Rules 2001 The words "or notary Public" shall be inserted between the words "Magistrate of the First Class" and "that the contents".
- 8) Following rules shall be added after Sub-rule (8) of Rule 21 of the Jharkhand Shops and Establishment Rules 2001.

Rule 2(9) :- Every order issued by or settlement arrived before The Labour Court or designated authority for the said purpose shall be executed in accordance with the procedure laid down for execution of orders as decree of a Civil Court under Order 21 of the Code of Civil Procedure 1908.

Rule 2(10) :- The Labour Court or designated authority for the purpose as the case may be shall transmit any order or settlement to a Civil Court having territorial jurisdiction and such Civil Court shall execute the order or settlement as if it were a decree passed by it."

- 9) The word "renewal " used in Rule 27(A) of the Jharkhand Shops and Establishment Rule 2001 is hereby repealed.
